A Place to Grow offers an inclusive program specializing in serving children with developmental delays. The American Red Cross not only provides relief to Lincoln County residents after a disaster has hit but also assists with installing smoke alarms in order to prevent disasters from becoming much worse. The Boy Scouts provides programs for boys in our community that help in team building, character and leadership building. Communities in Schools provide mentors to students in order to reduce the number of students dropping out of school. Gaston Family Health Services assists individuals in obtaining the medications they need even if they have no insurance. Hospice not only serve patients during the last moment of their lives but they also provide family members with social, emotional and grief support. Lincoln County Coalition Against Child Abuse provides services that assist victims of various types of abuse while also assisting with training to various departments that help with the capture and prosecution of the abusers. Lincoln County Coalition Against Domestic Violence provides a safe place for victims of
